PRESIDENT'S REPORT AUGUST 1973

- 1. Our Constitution has been re-typed and submitted again to the Crown Law Department and we are confident that it will be duly accepted.
- 2. In the ten months of the operation of our Welfare Office we have dealt with 1,054 cases.
- You will note that the numbers are increasing, proving the need for the services we are providing, and the recognition within the Greek community of their value.
- New directions have developed in our services recently. Three times a week our volunteers drive a lad to hospital for treatment; and one Welfare Officer, Mrs. Coutoupes, took an active part in providing on-the-spot aid to a family in danger of being left without shelter due to the requisition of its home. As we improve our organization we must be prepared to undertake more of such outside activities, and not become office-bound.
- 3. Our volunteers are slowly growing in number, but there is need for more, and to those who can spare the time, I strongly recommend the thought that one day per week aiding this work can be very rewarding. Mrs, Coutoupes is the central figure among our volunteers; without her our work would not have gone ahead. She has been helped by Mrs. A. Cassimatis, Mrs. A. Matthews, Mrs. M. Moraitis, Mrs. Gounaris, Mrs. R. Pallas, Mrs. R. Packer, Mrs. P. Doubaras, Mrs. D. Polites
- We thank these people most sincerely for their valuable Contributions. Thanks, too, to Eva Coutoupes for her typing.
- 4. We have taken steps to obtain tax deductibility for donations to our society, and have high hopes of achieving this.
- 5. We hope to join both the Victorian and Australian Councils Of Social Service, and several of our committee members take part in the Fitzroy Ethnic Action Movement. In this way we hope to interact with other people and organisations in the welfare field in order to become aware of and help to bring about further improvements.
- 6. Some months ago we received a grant from the Commonwealth Government for the employment of a social worker. We advertised the position but received one reply only. We answered this but have had no further word from the applicant.
- 7. There is a possibility that an office could be provided for the opening of a branch of our activities in Prahran, but we would require more volunteers before we could undertake this. We hope to be able to manage it in the near future.
- 8. I have been involved in the Victorian Task Force on Immi-Gration, and put forward several recommendations based upon The experience of our society's work. They have gone to the Minister for Immigration their outcome will be of great interest to us.
